The Social Services Transportation Advisory Council (SSTAC) is one of the four standing committees of StanCOG. It is comprised of 10 members of Stanislaus County that are appointed by the Executive Committee. According to the adopted Bylaws, the StanCOG Social Services Transportation Advisory Council (SSTAC) requires new members to be appointed by the StanCOG Executive Committee. Each member serves a 3-year term, and may be re-appointed by the StanCOG Executive Committee for an additional 3-year term. The SSTAC meets on the first Tuesday of each month, provides input on transit issues, including the coordination and consolidation of specialized transportation services, review and recommend action on the annual state mandate unmet transit needs assessment process.

Recommendation

By Motion, appoint Scott Calkins as a new Member of the Citizens Advisory Committee.

Background

The CAC is one of the four standing committees of StanCOG. It is to be comprised of 15 residents of Stanislaus County that are appointed by the Executive Committee. Each appointment is for a term of four years, with no Member serving on the CAC for more than eight consecutive years.

There are currently seven members on the CAC due to the resignation of several Members in the past year. The CAC meets once monthly, providing input on agenda items that go through the Committee structure before reaching the Policy Board.

Discussion

Scott Calkins expressed interest in joining the CAC through attendance at several recent StanCOG meetings. One of the meetings was the State Route 132 West Scoping Meeting and the other was the February CAC meeting. He then completed the attached CAC Membership Application and submitted it to StanCOG for membership consideration.

Mr. Calkins is a Modesto High School teacher who grew up on a small almond farm just west of Modesto where his parents still live. He is an avid bicycle commuter who rides to work most days. He is interested in how to improve transportation to make the county a safer place to walk and bicycle to work in order to protect air quality and quality of life for people of all ages. Background, Education and Experience: I am a lifelong resident of Stanislaus County. I have a B.A. in History and a teaching credential from CSU Stanislaus. For the past fourteen years I have been a teacher for Modesto City Schools. My teaching assignments have been in social science beginning with 7th grade at Roosevelt Jr. High, to my current position teaching government and economics to seniors at Modesto High. Before becoming a teacher I worked in retail for Longs Drugs on McHenry for ten years. I grew up on a small twenty-five acre almond farm just west of Modesto where my parents still live. My in-laws also have a small sixty-acre almond farm in the county. I am an avid bicycle commuter and ride to work an average of 150 days per year.

What Planning Issues Are Of Particular Interest/Concern To You? I am interested in all types of planning issues and how they affect the future of the people I live with and work with in Stanislaus County. I want planning to consider how important the roles of farmers have been to the county since it was created. We should not take this excellent farmland for granted. I am also interested in how we can improve transportation to make the county a safer place to walk and bicycle to work in order to protect air quality and improve quality of life for people of all ages. Planning for improvements to Highway 132 West of Modesto are of special interest to me because I have lived my whole life in this part of the county and feel like I know the area and the people there.
