# B. Discussion – Potential Development of a Transportation Expenditure Plan Framework for the Stanislaus Region Update

Carlos Yamzon provided an update on information he gathered since the last Executive Committee meeting, and Chair Charlie Goeken summarized some of the comments, concerns and discussion from the last Policy Board meeting regarding this topic. Carlos Yamzon sought feedback regarding potential next steps. The consensus of the Executive Committee was that a potential measure could not pass in today's economic times at the 2/3 level but recommended keeping the topic in mind in case the percentage necessary to pass one were to be lowered. It was also suggested that a potential project list be discussed in the interim, and that the discussion should continue at Policy Board meetings. Bill Bassitt noted that in a recent economic survey the Alliance conducted to area businesses, transportation/road concerns had not rated very high at all.

#### C. Discussion – Policy Board Workshop Follow Up

Carlos Yamzon said that a meeting was being arranged between members of the San Joaquin (SJCOG) and StanCOG Executive Committees regarding potential coordination between the two agencies. Rod Attebery noted that the Regional Policy Council was a tool already in existence through an MOU between the eight valley COGs to work together that might be used more effectively for the purpose that was being discussed.

Carlos Yamzon provided information on the upcoming CalCOG Regional Leadership Forum.
