Carlos Yamzon explained that this was the last budget amendment of the fiscal year. The main adjustment was a decrease of \$120,000 for a study that would be moved to FY 2014/15.

Carlos Yamzon reviewed the budget which showed decreases from the current year. He presented proposed adjustments in the Salaries and Benefits line item and a discussion took place regarding staffing.

*By Motion (Member Garrad Marsh/Member Vito Chiesa), and a unanimous vote, the Executive Committee recommended that the Policy Board adopt Resolution 13-32 to approve the FY 2014/15 Budget and Overall Work Program.
