1. CALL TO ORDER

Chair Bill Zoslocki called the meeting to order at 12:07 pm.

*By Motion (Member Gary Soiseth/Member Terry Withrow), and a unanimous vote, the Executive Committee approved the Consent Calendar.

5. DISCUSSION/ACTION ITEMS

A. Motion to Recommend Policy Board Adopt by Resolution the Non-Compliance Penalty for Required Recovery Ratio FY 2015/16 - City of Ceres Dave Reed explained that the City of Ceres had been identified as being non-compliant for FY's 2014/15 and 2015/16 in meeting farebox requirements and that a \$22,710 penalty was recommended to be imposed that would be redistributed to the other three providers. He also said that the transit managers would be discussing the

issue of meeting farebox at a meeting in May and that the Management and Finance would be reviewing the information at their June meeting.

*By Motion (Member Vito Chiesa/Member Gary Soiseth), and a unanimous vote, the Executive Committee recommended that the Policy Board adopt by resolution the Non-Compliance Penalty for Required Recovery Ratio FY 2015/16 — City of Ceres.

B. Motion to Recommend Policy Board Approve Resolution Identifying the Rural Alternative Transit Study Pilot Project as a Measure L Funding Priority Rosa Park provided information about a transit study that the eight MPO's in the San Joaquin Valley had received a grant to conduct in which a pilot project was recommended to assist disadvantaged communities within Stanislaus County with mobility options. She said that a grant application was being prepared to fund the pilot project and that it required a commitment for a local match.

*By Motion (Member Vito Chiesa/Member Gary Soiseth), and a unanimous vote, the Executive Committee recommended that the Policy Board approve a resolution identifying the Rural Alternative Transit Study Pilot Project as a Measure L Funding Priority.

Rosa Park reviewed the May agenda and noted that Item 6D would instead be on the June agenda.
