KEEP AN EYE ON YOUR TAX DOLLARS

Measure L is the Transportation Ordinance and Expenditure Plan approved by Stanislaus County voters on November 8, 2016. The measure raises the sales tax in Stanislaus County by one-half cent for a total period of 25 years to improve our local streets and roads, improve connectivity and reduce congestion. This money is administered by the Stanislaus Council of Governments (StanCOG) and pays for specific voter-approved transportation projects for local street and road improvements, and regional projects and transit programs specified in the Plan.

Measure L calls for an independent Measure L Oversight Committee to oversee compliance with the Ordinance as specified in the Transportation Ordinance and Plan.

The responsibilities of the 10-member Measure L Oversight Committee are to:

- Ensure all transportation revenue collected from Measure L is spent in accordance with the Measure L Ordinance and Expenditure Plan;
- Hold public meetings as necessary regarding the expenditure and status of funds generated by Measure L;
- Review independent audits of the expenditure of tax funds and implementation of the programs and projects in the Expenditure Plan; and
- Issue an annual report on its findings regarding compliance with the requirements of the Expenditure Plan and the Ordinance to the StanCOG Board.

HOW ARE MEMBERS CHOSEN?

Measure L Oversight Committee candidates are chosen by the City Council or Board of Supervisors they represent. All applications are sent to StanCOG and then will be provided to the member agencies for their review. Staff at each agency will individually screen all applications, and conduct interviews and recommend candidates for consideration by the elected officials.

Measure L Oversight Committee members represent each of StanCOG's member agencies. Each agency appoints one member to represent its residents.

MEMBER VACANCIES

Currently, there are vacancies for representatives for Stanislaus County and the cities of Newman, Turlock and Waterford. These are volunteer positions and no monetary compensation is paid to committee members. The chairperson is selected by the members of the committee.

WHO CAN APPLY TO SERVE?

Any Stanislaus County citizen 18 years or older may apply to serve on the Measure L Oversight Committee. Potential candidates will be reviewed on the basis of the following criteria:

1. Commitment and ability to participate in Oversight Committee meetings for a three-year term. The Committee will maintain time and meeting requirements. The Committee will meet quarterly.
2. Demonstrated interest and history of participation in community activities, with special emphasis on transportation-related activities.
3. Lack of financial conflict of interest with respect to the allocation of sales tax revenue generated by Measure L.
4. Elected or appointed city, district, county, state or federal officials are not eligible to serve.
5. Members of any StanCOG Advisory Committee or other Authority are not eligible to serve.
