3. Accept the minutes of SSTAC Meeting for March 12 and April 9, 2008 as follows:
By Motion, (Villines and Erickson) and unanimous vote by Council, approved the March 12, 2008 and the April 9, 2008 minutes. As Amended.

4. Transit Grant Programs Update

- **JARC/New Freedom:** Scott Philips from StanCOG spoke on this item stating that there are still some application issues with FTA. He has a meeting arranged with the FTA representative next week, who is responsible the allocation of these funds. Mr. Philips stated that the difficulty with this specific program is having the high dollar match requirements.
- **Proposition 1B Transit Programs/PTMISEA/Homeland Security:** Mr. Philips stated that funds received for this program are to enhance rider security. He received an email from the Homeland Security Program Director last week stating that everything looks fine. Mr. Philips stated that he expects funds to be allocated from this program in the near future.
- **Federal Transit Administration Section 5310 – Elderly and Disabled Specialized Transit Program:** Mr. Philips stated that he knows of several applicants looking to submit applications , which are due at the end of the month. He stated that he can work with applicants if they are not able to submit an application by StanCOG's due date of June 02, 2008. Mr. Philips stated that he is seeing a lot of positive results from non-profit

7. Transit Managers Reports

Mr. Christian stated that he would like agencies to provide "Cal Act", which stands for: "California Association for Coordinated Transportation" Mr. Christian highly recommends membership with this organization.

Bill Latham, City of Modesto, discussed issues with Paradise Road out to Martin Luther King. He stated this is a high demand area and is hoping to get services started on Monday, May 12th.

Mr. Downs reported for Donna Bridges, stating she had sent him an email noting 5 comments about ROTA (please see attached).

Mr. Truax requested two things in his report:

7. Federal Transit Administration Section 5310 – Elderly and Disabled Specialized Transit Program

Scott Philips (StanCOG) updated the Council on the JARC/NF, Prop 1B Transit Programs, and FTA Section 5310 activities. He informed the members that applications for Section 5310 funds may be submitted to the StanCOG office up to July 31, 2008. Mr. Philips also explained potential uses of Section 5310 funds.

8. Unmet Transit Needs Update/Roundtable

This item was covered under Agenda Item No. 2 "Comments from the Public". Brad Christian updated

the Council on the Transit Needs Assessment Study. He stated that two firms have submitted proposals. The Study is projected to be completed by February 2009.

9. Transit Managers Report

Scott Madeiros, City of Turlock

- Turlock transit is offering free rides (DAR and fixed route) to the 'cooling station' location at the Salvation Army Turlock site.
- Ridership has been flat (approximately 20% below last year).

Brad Christian, Stanislaus County

- Ridership is up 10% over last year.
- Changes to the Turlock-Modesto Shuttle will be effective August 4, 2008
- Effective June 30, 2008, the Medivan South ceased operation
- Due to the termination of Medivan South, Route 70 will run from Modesto-Turlock-Merced

6. Executive Director's Report (Lark Downs for Vince Harris)

- Jill Erickson has informed StanCOG that she wishes to withdraw from the SSTAC.
- If approved tonight by the StanCOG Executive Committee, Sandra Williams and Misty Ridenour will become SSTAC members.
- Policy Board approved FY 1008/08 Overall Work Program and Budget. Included was the Transit Coordinator position at an increased salary level.
- Sales Tax Measure EIR and Ordinance are on tonight's Policy Board agenda. If approved, the County Board of Supervisors has until August 8 to approve it for the November Ballot.
- Blueprint Workshops are continuing through July 17

7. Comments from Council Members

Vice-chair Truax requested that staff contact DRAIL Director Terry Platt and ask if he would be interested in becoming a SSTAC member. Chairman Truax felt it important that DRAIL be represented, and felt that Mr. Platt would be an excellent candidate.
