1. CALL TO ORDER

Chair Terhesa Gamboa called the meeting to order at 6:00 pm.

- 4. CONSENT CALENDAR
 - A. Motion to Approve Citizens Advisory Committee (CAC) Minutes of 11/5/14
 - * By Motion (Member Constance Anderson/Member Jeffrey Goschen), and a unanimous vote, the Citizens Advisory Committee approved the Consent Calendar.

5. DISCUSSION/ACTION ITEMS

A. Final FFY 2013-2014 Local Assistance Delivery Formula Obligational Authority (OA) Funds Report

Jeanette Fabela gave an overview of the Local Assistance Delivery Formula Obligational Authority (OA) Funds. She stated that the StanCOG region had done an outstanding job of obligating OA funds in FFY 2013/14. She explained that the region not only secured all federal apportionments but had ranked as the fourth highest region in over-obligation, in California. A discussion followed and members' questions were answered.

B. PTMISEA Funds Allocation

Regina Valentine reported that last month, StanCOG staff met with the transit operators to determine the distribution of the FY 2014/15 Proposition 1B Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA) Program funds. She stated that for FY 2014/15, StanCOG received approximately \$5.5 million in PTMISEA funds for distribution to the region for transit Capital Projects, and that the Project Allocation list had been provided with the staff report. The Policy Board had approved the project list via Resolution 14-16 at their November 19th meeting.

- C. Motion to Recommend Policy Board Adopt Resolution to Approve California Transit Security Grant Program - California Transit Assistance Fund (CTSGP-CTAF) Allocation Regina Valentine stated that StanCOG was a designated recipient of the voter-approved Proposition 1B Transit Security Grant Program funds for the Stanislaus region. She reported that approximately \$413,000 was allocated to StanCOG in FY 2013/14, and said that Stanislaus County had requested to receive the region's available funds for their eligible projects. Members' questions were answered.
 - *By Motion (Member Chris Esther/Member Elizabeth Claes), and a unanimous vote, the Citizens Advisory Committee recommended that the Policy Board adopt the resolution to approve the California Transit Security Grant Program California Transit Assistance Fund (CTSGP-CTAF) allocation.

D. Low Carbon Transit Operations Program

Regina Valentine provided an overview of the Caltrans Low Carbon Transit Operations Program (LCTOP). She stated the LCTOP had been created to provide operating and capital assistance for transit agencies to reduce greenhouse gas emission and improve mobility, with a priority of serving disadvantaged communities. She said that under the LCTOP program, the Stanislaus Region would receive approximately \$184,000 in FY 14/15. She also reviewed the timeline for the agencies to submit their allocation requests.
