1. CALL TO ORDER

Chair Bryan Whitemyer called the Management and Finance Committee meeting to order at 12:15 pm.

 - A. Motion to Approve Management and Finance Committee Minutes of 2/5/14

*By Motion (City of Hughson/City of Riverbank), and a unanimous vote, the Management and Finance Committee approved the Management and Finance Committee Minutes of 2/5/14.

5. DISCUSSION/ACTION ITEMS

A. Valley Vision Stanislaus Plan Development and Schedule Update

Jaylen French provided a brief update on the final stages of the Valley Vision Stanislaus process which would be culminating in the Regional Transportation Plan/Sustainable Communities Strategy (RTP/SCS). He said the documents would be released for a public review and comment period and public hearings would be held before being presented to the Policy Board for adoption in June. He

mentioned that the Department of Housing and Community Development (HCD) was opening discussions with a statewide stakeholders group to discuss the RHNA process.

B. Transportation Expenditure Plan Update

Carlos Yamzon provided an update on presentations made to the City Councils and the Board of Supervisors. He said he had visited all jurisdictions except for Modesto and Newman which were scheduled for that night, and that thus far, all had provided Resolutions of Support. He also reported that the Policy Board approved polling to be done and that it had begun the previous Sunday with results scheduled for the March 19th Policy Board meeting. Matt Machado said that the County had already developed their individual expenditure plan, and it was suggested that each jurisdiction should do the same.

C. Motion to Recommend Policy Board Adopt Resolution 13-28 to Authorize Cooperative Funding Agreement and Release of Request for Proposal for a Feasibility Study for the South County Corridor (SCC)

Carlos Yamzon explained that additional funds were required to prepare a Feasibility Study and that Stanislaus County and the Cities of Turlock, Patterson and Newman had provided verbal support to provide the funding. It was noted that approval was still required by the City Councils of the cities involved.

- *By Motion (City of Turlock/City of Newman), and a unanimous vote, the Management and Finance Committee provided a conditional recommendation that the Policy Board adopt Resolution 13-28 to authorize a Cooperative Funding Agreement and Release of Request for Proposal for a Feasibility Study for the South County Corridor, recognizing that City Council approval was still required from the cities involved.
- D. FY 2014/15 Unmet Transit Needs Identification and Analysis Report and Finding Mike Costa provided a summary of the annual Unmet Transit Needs Assessment process which had been conducted over the previous months. He said extensive outreach was done that included multiple presentations and public hearings throughout the region to gather public comments regarding potential unmet transit needs. He said 24 comments were received and that two fit the definition of an unmet transit need. The two comments were analyzed and it was determined that they did not meet the definition adopted by the Policy Board as reasonable to meet.
