5. PRESENTATION

A. MOVE Annual Report

Stacie Morales provided an update on the activities of MOVE, Transportation that Changes Lives, formerly known as the Consolidated Transportation Services Agency of the Stanislaus Region. She reviewed three programs (Travel Training, Bridges Volunteer Driver Program and Vets Van

Volunteer Driver Program) that MOVE manages and summarized the increase in services provided over the past year.

6. NOTICE OF UPCOMING PUBLIC HEARINGS

A. FY 2017/18 Unmet Transit Needs Public Hearing Schedule

Stephen Hanamaikai announced the schedule for three upcoming public hearings for the FY 2017/18 Unmet Transit Needs assessment. He noted that the dates were inverted on the staff report in the agenda packet and provided a corrected version. The public hearings were scheduled for October 19th in Modesto, November 10th in Oakdale and January 11th in Patterson.

- A. Motion to Recommend Policy Board Approve the Meeting Schedule for Calendar Year 2017 Cindy Malekos indicated that a meeting schedule for calendar year 2017 for the Management and Finance Committee was proposed that followed with the current date and time schedule of the first Wednesday of the month at 3:00 pm. She said there were two exceptions in October and December where the meeting time had been moved up a week.
 - *By Motion (City of Patterson/Stanislaus County), and a unanimous vote, the Management and Finance Committee recommended that the Policy Board approve the Management and Finance Committee meeting schedule for calendar year 2017.
- B. Joint Exercise of Powers Agreement (JEPA) for State Route 132 West Freeway/Expressway Elisabeth Hahn stated that Stanislaus County, the City of Modesto and StanCOG had developed a draft JEPA to coordinate actions in the next phase of the SR 132 West Freeway/Expressway project. Toby Wells asked why StanCOG would serve as a member of the JEPA. Rosa Park indicated that the Policy Board asked staff to look into establishing a JEPA back in November 2014. She said the StanCOG representative would be from another city that is not part of the 132 corridor. Toby Wells asked if the JEPA would receive the contracting benefits that Modesto receives as a charter city.

 Rosa Park provided an update on educational presentations being conducted in the communities.
