RE: Administrative Amendment #16 (Type 1) to the Stanislaus Council of Government's 2009 FTIP

Mr. Aljabiry:

The Stanislaus Council of Governments (StanCOG) Policy Board has authorized its Executive Director to approve Administrative Amendment #16 to StanCOG's 2009 FTIP. The purpose of this letter is to notify Caltrans, FHWA and the FTA that an administrative amendment has been authorized and approved. A summary of changes to projects listed in the 2009 FTIP is attached as well as each project's corresponding CTIPS page. The financial tables have also been revised to reflect funding changes.

Modifications included in this Administrative Amendment meet the criteria identified in the letter issued by FHWA on November 17, 2008, regarding revised Federal/Statewide Transportation Improvement Program Modification Procedures. Per these "Procedures", StanCOG is issuing "minor" changes related to project cost, selection or programming that do not interfere with the timely implementation of any approved TCMs project. None of the project modifications within this amendment require a re-determination of the air quality conformity analysis. Administrative Amendments to the FTIP used in lieu of Formal Amendments are not subject to FHWA approval.

Administrative Amendment #16 modifies the following projects:

City of Modesto:

- Add project to RSTP Lump Sum back up list
- Transfer \$1,017,981 from FFY 09/10 RSTP Lump Sum apportionment to the MAX Bus Maintenance Facility Project

City of Ceres:

- Modify CMAQ funding moving from CON to PE \$20,000 Federal \$ 2,591 Local Match

This Administrative Amendment is in accord with Caltrans' Administrative Modification policy as the funding modification does not exceeded 25% of total project cost nor \$5,000,000 for a single modification.
