Subject: Approval of Administrative Modification #19 (Type 1 Amendment) to the Stanislaus Council of Government's 2011 FTIP

Dear Mr. Aljabiry:

On November 10, 2011, with the acknowledgement of the StanCOG Policy Board, the California Department of Transportation (Caltrans) delegated to the StanCOG Executive Director the authority to approve Administrative Modifications to the Federal Statewide Transportation Improvement Program (FSTIP)/Federal Transportation Improvement Program (FTIP). This delegated authority is in accordance with the revised FSTIP/FTIP Amendments and Administrative Modification Procedures dated June 3, 2011.

The Stanislaus Council of Governments (StanCOG) Executive Director has completed the review of StanCOGs' Administrative Modification No. 19 to the 2010/11 – 2013/14 Federal Transportation Improvement Program (FTIP). This administrative modification **adds programming capacity of \$0 in funds** to the current financial plan for the Stanislaus Council of Governments FTIP that relies on the State's federal programming capacity.

The Executive Director finds that these proposed changes are consistent with the FSTIP/FTIP Amendment and Administrative Modification Procedures and approves these changes. The administrative modification is described in the attachments.

Under this delegated authority, an administrative modification does not require Federal Highway Administration, Federal Transit Administration or Caltrans approval. This change is effective

immediately and therefore reflected as an administrative modification to California's 2011 FSTIP and StanCOG's 2011 FTIP per the date of this memo.
