1. CALL TO ORDER

Vice-Chair Bill Zoslocki called the meeting to order at 6:00 pm.

2. PLEDGE OF ALLEGIANCE

The pledge was led by U.S. Representative Jeff Denham.

4. PUBLIC COMMENTS

Scott Calkins questioned the support of Measure L in the upcoming election. Rhett Calkins asked about the Policy Board Travel Policy. Member Terry Withrow introduced his daughter, Emma Withrow, who was in attendance.

*By Motion (Member Mike Van Winkle/Member Richard O'Brien), and a unanimous vote, the Policy Board approved the Consent Calendar.

6. PRESENTATIONS

A. U.S. Representative Jeff Denham, California, 10th District

Congressman Denham provided an update on issues Congress was working on such as the water bill and the improved method of disbursing funding to the states from FAST Act programs. He also said he was supportive of Measure L because of the improvements that could be made to the region's infrastructure.

B. MOVE Annual Report

Stacie Morales provided an update on the activities of MOVE, Transportation that Changes Lives, formerly known as the Consolidated Transportation Services Agency of the Stanislaus Region. She reviewed three programs (Travel Training, Bridges Volunteer Driver Program and Vets Van Volunteer Driver Program) that MOVE manages and summarized the increase in services provided over the past year.

7. PUBLIC HEARING

A. FY 2017/18 Unmet Transit Needs Public Hearing

Stephen Hanamaikai reviewed the Transportation Development Act's Unmet Transit Needs Assessment Process. The Public Hearing was opened at 6:29 pm. There were no public comments. The Public Hearing was closed at 6:30 pm.

8. DISCUSSION/ACTION ITEMS

A. Motion to Adopt by Resolution 16-10 the Joint Exercise of Powers Agreement for State Route 132 West Freeway/Expressway

Elisabeth Hahn stated that Stanislaus County, the City of Modesto and StanCOG had developed a draft JEPA to coordinate actions in the next phase of the SR 132 West Freeway/Expressway project. Rhett Calkins and Scott Calkins questioned why the JPA was needed. Member Bill O'Brien indicated that it was modeled after the North County Corridor JPA. He invited anyone interested to attend the next NCC meeting which was scheduled for November 16 at 4:30 pm. Member Terry Withrow said that the JPA would allow for a focus solely on the SR 132 West project. Rod Attebery indicated several clerical changes needed to be made to the JEPA which were not substantive in nature.

*By Motion (Member Richard O'Brien/Member Matt Beekman), and a unanimous vote, the Policy Board adopted by Resolution 16-10 the Joint Exercise of Powers Agreement for the State Route 132 West Freeway/Expressway with the understanding that clerical changes could be made by the Executive Director that were not substantive in nature, but if they were, the item would be returned to the Policy Board.

B. Measure L/Transportation Expenditure Plan for the Stanislaus Region Update Kendall Flint reviewed some of the recent educational outreach that had been done. She reminded members about the website, www.stanislaus-localroadsfirst.com, where educational information was available. Constance Anderson asked about an ad that was in the Modesto Bee

that day regarding Measure L. Kendall Flint clarified that the ad was not done by StanCOG, and that it had some misstatements in it.
