1. CALL TO ORDER

Chair Bill Zoslocki called the meeting to order at 6:05 pm.

4. PUBLIC COMMENTS

Scott Calkins inquired about work being done on the stockpiles near the proposed State Route 132 West project. Kendall Flint, representing the City of Modesto, announced that notices had been sent to property owners in the area to notify them about the work. She said that it was typical testing and information gathering that was done in the planning process of projects. Ben Calkins spoke on his support of increased mass transit in the region to address congestion instead of the SR 132 West project.

On behalf of the Policy Board, Chair Zoslocki expressed his appreciation to Constance Anderson for her four years of service representing Turlock on the CAC.

B. Recognition of Service on the StanCOG Bicycle Pedestrian Advisory Committee (BPAC) by Lennox Harris and Chuck Shoup

Chair Zoslocki, on behalf of the Policy Board, thanked Lennox Harris for representing Patterson for eight years on the BPAC, and Chuck Shoup for representing Stanislaus County for eight years on the BPAC.

C. Recognition of the Appointment of Paul Van Konynenburg to the California Transportation Commission (CTC)

Chair Zoslocki introduced new Commissioner Paul Van Konynenburg who expressed his appreciation for all the support on his recent appointment to the CTC. He said the CTC was meeting in Modesto on October 18-19 and encouraged members to attend.

7. PUBLIC HEARING

A. StanCOG Draft 2018 Regional Transportation Improvement Program (RTIP) 30-Day Public Comment Period and Public Hearing

Lakshmi Rajagopalan announced that the Draft 2018 RTIP had been prepared and was released for a 30-day Public Comment Period from October 1-30. Chair Zoslocki opened the Public Hearing at 6:41 pm. Scott Calkins asked about the Performance Measures in the RTIP. Ben Calkins did not think the SR 132 project in the RTIP would improve congestion. The Public Hearing was closed at 6:44 pm.

Karen Kincy reported that over \$12 million had been received as of September 15th. Kendall Flint indicated a Policy Board workshop would be scheduled to discuss the prioritization of regional projects.

Rosa Park indicated that Tiger and INFRA grant applications were being submitted by Stanislaus County and the City of Modesto for the North County Corridor and SR 132 West projects. There was consensus that the Fulkerth Turlock project be considered for this program. She also reminded members about the CTC meeting on October 18th.
