**B. Motion to Recommend the Policy Board Accept by Resolution the FY 2021/22 Measure L Annual Report**

Isabel Garcia reviewed the annual report that had been prepared for Measure L, the 25-year ½ cent sales tax that Stanislaus County voters approved in November of 2016. She said that Measure L provided funding for local transportation improvements, and in FY 2021/22, Measure L funds were distributed to all jurisdictions for their projects.

**C. Public Hearing Announcement for the FY 2023/24 Unmet Transit Needs (UTN) Analysis**

Clarissa Hernlund provided an overview of the FY 2023/24 Unmet Transit Needs (UTN) process. She said that a public survey was available in both English and Spanish on SurveyMonkey, and that public hearings would be held at the January 18th Policy Board meeting, and on Monday, February 13, at 6:00 p.m. via Zoom.

**D. StanisCruise Implementation Update**

Clarissa Hernlund discussed that as of January 1, 2023, StanCOG was now the leader of the Transit Demand Management (TDM) program, StanisCruise. She said the former program was known as Dibs and that it serviced San Joaquin, Stanislaus, and Merced Counties. She also provided an example of how to plan a trip on the new app.
